Jerry and committee members offered thanks and well-wishes to the students who will be ending their tenure with the Campus Planning Committee.

### **PERFORMING ARTS LONG-RANGE PLANNING PROGRESS**

The progress of the Performing Arts Long-Range planning process was shared. The plan is to identify appropriate spaces and use them more efficiently by the UI community, as well as by surrounding communities. At this point, sites and locations have been identified as *sharable*, *difficult to share* or *under special circumstances* as to what type of space can be shared. Next will be to identify those who might consider these spaces, while taking into consideration the support personnel required to run the space while providing equal access. This process may setup a model for future use of other campus spaces.

### **MILITARY SCIENCES / IVETS FACILITY**

Programming has begun for a single facility or perhaps multiple facilities to accommodate the Military Sciences and IVETS program on campus is progressing through the planning process. This will be brought back for committee review.

### **ART DISPLAY PLANNING PROGRESS**

The development of the Art Display Planning layer is moving slowly, but still progressing.

### **ART AT PAPPAJOHN BUSINESS BUILDING**

An opportunity to acquire a sculpture from Nigel Hall to place in the courtyard at the Pappajohn Business Building has come up. Committee members were in support of the sculpture and its location but did have concerns about accessibility and labeling.

### **ART AT GIBSON SQUARE**

Reinvigoration of Gibson Square with installation of select pieces of art was discussed. With the envisioned space as a more urban park setting, questions were raised as to a potential change in philosophy for use of this space and the approachability and engagement of this art.

### **ILLUSTRATIVE PLAN REVIEW – OUTLYING AREAS**

Illustrative plans of the west campus were shared.

- West Lawn site conceptual site use.
- College of Public Health expansion
- Old Art Building conceptual site use south of building
- Grand Avenue redirect to Melrose Avenue
- Culture Center area conceptual site use
- South Quad to remain short-term
- Field House to remain short-term as a site holder
- Old Pharmacy to remain short-term as a site holder
- Proposed Wrestling Facility near Carver-Hawkeye Area
- Finkbine development with partnership – not near-term
- Athletic Sports Complex conceptual development on the far West campus
